Annual membership dues must be paid in full by May 15, 2024 to avoid a \$50.00 late fee. The new family membership is \$900 with the annual renewal fee of \$450. The new senior membership is \$850 with an annual renewal of \$400. New single membership is \$800 with an annual renewal of \$350. We offer a few payment options to accommodate our members. 1.		<b>Annual dues</b> - payable by May 15th of the current year. <ul style="list-style-type: none"> <li>● A \$50 penalty will be added to any account past due unless arrangements have been made with the Business Manager.</li> <li>● You must pay dues by May 1<sup>st</sup> for information to appear in the Yearbook.</li> <li>● Access to the pool and facilities will not be allowed if payment is not received, and forms are returned, or arrangements are made by opening day.</li> </ul>
2.		Members' dependents or children under the age of 24 residing in the household shall be entitled to use all corporate facilities. *
3.		College students under the age of 24, residing as a guest in members' household shall be entitled to use all corporate facilities. *
4.		Dependents and children residing in members' household who have dependents or children of their own must apply and hold their own membership. *Any other configuration of a household must be approved by the Board of directors.

	5.	Guest of members may use the facilities upon payment of such charges approved by the Board of Directors. It is the responsibility of the members to instruct their guests on the pool rules. If a guest violates pool policy, he or she will be asked to leave and will no longer be granted admission to the facility for the remainder of the season. The host member may lose his or her guest privileges for up to the entire season.
	6.	A club member must accompany all guests and purchase a guest pass. If the member leaves, all guests must also leave the facility. No Exceptions.
